2005 REUNION PLANS GET UNDERWAY

Wednesday, Oct. 5th is Registration Day, but as usually is the case, we are sure that many of our members will have arrived a day before on Tuesday.

The first order of business will be the setting up of The Hospitality Room, where Registration will be held.

Wednesday Evening will also be the first Informal Board Meeting of The Association Board of Directors and the Foundation Board of Directors.

There are no other formal plans for Wednesday Evening at this time, but that may change before the next issue of The Bugle comes out (Jun-Jul), and if it does, The plans will be announced then.

Thursday we will board our buses in front of the hotel at 8:00 A.M. and head on out for Pine Mountain, Georgia. Here we will change into special Safari Buses for a tour of the Wild Animal Safari Park. This extremely outstanding tour through this unique facility is explained and outlined in detail in the story on Page 28+29 of this issue. From Editor & President's Desk

This October's Reunion of our 17th Infantry Association should be the most spectacular ever held. It was just a little more than one dozen years ago, when LTG "Buffalo Bill" Quinn and the 17th Infantry Regiment Association East, united with COL Jake Wittler's 17th Infantry Association, West to form the National Association we are today.

From the 1954 first joint Reunion in Ft. Lauderdale, Florida, we have grown from a few hundred to what we are today with a membership of nearly one

thousand.


The concept that we should be exceptionally proud of today is that our membership everan contains increasing number of today's young soldiers. We of WW-II, Korea, and Vietnam are aging. It is no surprise to realize that as time passes, our numbers decrease. Without the influx of the soldiers of today, our Regimental Association would pass on and be forgotten. If this were to happen, a great part of American History would be lost.

Now that we are about to construct a Monument at Ft. Benning, Georgia, the Home Of The U.S. Infantry, our place in History is assured. Our Association Members, Family and many Friends have come together and donated more than \$60,000.00 to build and maintain this Monu-

ment.

We had been talking about a Monument to be built at Ft. Benning, Georgia for many years, but in 2001 at our Reunion in Gig Harbor, Washington, a new member of the Association, Jack Reynoldson, proposed that we initiate the project to create the Monument. He forecast that he would be able to procure sufficient donations from the many Corporations in Washington, DC that he was associated with, to fund the major portion of the Monument.

Although the financial atmosphere was not conducive to his proposals at that time, Jack, his family and friends soon donated enough funds to



become a major donor to the

project himself.

Many of our members went themselves to Companies and Corporations they knew and solicited them for donations. One member in particular, John Graham had an idea, he figured that since we were with the Kentucky Rifles in 1812, why not solicit The State of Kentucky for a donation. He wrote the Governor and pitched the project and gave him my name. They called me and after subsequent discussions and sending them some documentation, they donated \$2,000.00 to our project.

Taking this action as a spur, I contacted the Governor of Alaska and solicited his office for a donation. After all, our current active unit is stationed in Alaska, and in 1943, the 17th Infantry kicked the Japanese Invaders off of The Aleutian Islands of Alaska. We haven't received anything yet, but the Legislature is meeting now and we believe that we will get a dona-

tion early this year.

I've also written The President of South Korea and received a response that they are considering a donation and they have forwarded the papers to The South Korean Consul General in Atlanta, Georgia, so we will just have to wait and see

what transpires there.

A few months after the initial project was started, our then new Secretary, Don Shook, informed me that a Life-Sized Bronze Buffalo was being offered for sale on the National Computer Auction known as Ebay. I checked it out and

quickly called the owner, viewed the Buffalo and polled our Board for the approval to purchase it.

We then obtained it for only \$7,000.00, about a third of its actual value. As this issue is going to press, our Buffalo is enroute from the warehouse facility where we were storing it in Wisconsin, to Macon, Georgia, where Clark Memorials Co., the contractor for our Monument is located. By the time this Bugle is in your hands, our Buffalo will be in Georgia.

Working with the Real Estate Officer at Ft. Benning and the Protocol Officer, I have obtained for us a significant program. The Officials there at Ft. Benning were extremely helpful and bent over backwards to help us along with the planning for the Unveiling and Dedication.

We will have an Army Band, a Color Guard, and a Rifle Team who will execute a 21-Gun Salute. Ft. Benning is arranging to set up 200-Chairs at the site for us. The possibility exists that we may get the Commanding General of The U.S. Infantry there to speak at the dedication.

Our own Chaplain Strube will also speak at the dedication, remembering those who could not be here for the ceremonies.

A complete story and the schedule of events to take place during these activities may be found on Page 28+29 of this issue.

One nice feature about the site for our Memorial at Sacrifice Field on Ft. Benning, is that it is located a short 30-yards from the entrance to the current National Infantry Museum.

This museum houses thousands of interesting and unique items and reflects the role played by Infantrymen in the defense of our Nation. More than two-hundred years of proud history are on display.

After the dedication ceremonies and unveiling of our Monument, I have scheduled an hour or so for those who wish to look through The Museum.

Our schedule is open Saturday afternoon, and as Ft. Benning is only about 15 to 20 minutes from our hotel, those who may wish to return Saturday afternoon for a more extensive tour might wish to do so.



OUR BUFFALO MONUMENT



In this issue in my view the "Long Pole in the Tent" is the report of progress made in funding our Monument. From our initial visit to Sacrifice Field at Ft Benning, Georgia through our visit to the Gettysburg Battlefield, where our 17th Regiment lost nearly 60% of their strength on the third day of the battle, our progress in raising funds and finalizing the design of our Monument has been outstanding!

President Stu Rothman's leadership and drive, assisted by our Staff and Board members has been notable! I belong to eight different Military Associations and our progress in erecting our Buffalo Monument at Ft Benning is the most impressive action I've seen - particularly for a Regimental sized unit!

More recently, we have learned that an outstanding soldier and member of the 17th Infantry Association, CSM Tim Green, has been spending his spare time helping children in Afghanistan. I hope many of you responded to his appeal for things he could use in his work

among the children.

Now in response to the Tsunami disaster, we see pictures American military men and women helping the unfortunate people in that devastated area.

My experience has been that American Military people are among the most caring and self-giving people I have had the privilege of knowing. Far too frequently our fellow citizens do not recognize it. Let me just say THANK YOU!


Most cannot afford or even obtain rudimentary things they need for health, education, creativity, and productiveness. That's where the great generosity of the American people



ONE OF YOURS NINE OF OURS

By the summer of 1952 the war in Korea had become the strange conflict of stalemate. Much like the First World War, the combatants were dug into trenches and bunkers with the conflict revolving mainly around reconnaissance patrols and platoon sized probes to test enemy strength and take prisoners for intelligence purposes.

In the summer of 1952, the U.S. Army's 3rd Battalion, 17th Infantry Regiment, 7th Division had positions north of to day's demilitarized zone along the 38th parallel. The 17th Regiment, called the Buffaloes, and its 3rd Battalion, called the Blue Buffaloes, held their Main Line of Resistance near Chorwon with the Kumwah Valley behind them. The action was mostly patrols and small unit encounters.

One former platoon leader recalls, "I arrived in Korea in May 1952. In my first six weeks in Korea, We had five casualties. Two men walked into a minefield returning from swimming. Two were shot coming back from patrol by our own guard because they didn't know the password, and the fifth had a heart attack. It was a very quiet war at the time."

The area had a huge hill on the right called 1098, since hills were named for their elevation. In the middle of the valley was a little hill called 202. The Chinese owned Hill 202, were well dug in, and constantly harassed our troops going to and

returning from patrol.

To relieve this situation, Company K of the 3rd Battalion, Blue Buffaloes, received orders to assault the summit of Hill 202, destroy the position and take

prisoners.

The platoon commanded by First Lieutenant Robert Adam Renneman was chosen to lead the assault. On the morning of 16 July 1952, Hill 202 was enveloped in a heavy shroud of mist. Bob took the lead position and moved his platoon out to make the assault. Company A, 73rd

Tank Battalion and the 1st.

Platoon 17th Regimental Tank Company were to provide direct fire support for the assault, but with the visibility so poor there was little they could do for fear of hitting their own troops. Those present remembered the morning as being eerily still and quiet as Bob's platoon moved out. One recalled, you could easily tell who Bob was because he was so much taller than everyone else, and he was in the lead.

When the mist lifted, all hell broke loose. The Chinese small arms fire was so thick you could almost see and feel it. They threw hand grenades, rolling them down the hill as they often did. Bob picked the grenades up with one hand while firing a semi-automatic weapon with the other, and threw the grenades back at the Chinese.

One observer reports, "You could see that he was hit several times because he was staggered. A veritable wall of fire came down from the top of that hill and we never saw a Chinese. Not one! They were so well dug in and so deep you couldn't see them. Bob finally fell, got up again exhorting his men to follow him. When he was finally downed for the last time he was so far in front of his unit that his body could not be recovered. So licking our wounds we came back."

The next morning the Blue Buffaloes saw something white on Hill 202. Looking at it through binoculars they could tell it was a shroud. It was placed so that our patrols would find it. Thinking it was a trap; the Blue Buffaloes hesitated to send out a patrol to investigate. After a debate that lasted throughout the day, they at last sent a heavily armed patrol to examine the white shroud.

Bob's body was under the shroud all washed and cleaned. The body was not booby-trapped as was the Chinese custom, and amazingly Bob's boots were still on his feet. His uniform had been repaired to close the bullet holes and his hands were crossed on his chest with his Naval Academy class ring still on his finger.

The Chinese also left a note on Bob's body. There are two accounts of what the note said. One is: "Brave soldier. Take him home." The other account: "One of yours for n ine of ours." The Blue Buffalo patrol brought Bob's body back to our lines without drawing fire from the Chinese. That too was remarkable.

As one observer reported, "That was not like the Chinese. The Chinese never before showed any emotion or did anything like that. They must have been struck by his brav-

erv.'

One who witnessed Bob Renneman's heroism recently said, "There hasn't been a week that's gone by since I saw that, that I haven't thought of Bob. You always hear about the Halseys and Nimitzes and Admiral Fletchers and all those great heroes of World War II. And others, like McCain and your POW classmates, who performed under unimaginable conditions.

But you never hear about people like Bob who did exactly what he was taught to do here at the Naval Academy. Leadership, honor, integrity; he had them all. I can still see that incredible hail of fire and Bob picking up hand grenades and throwing them back while shooting with the other hand. He died leading with incredible heroism. At the infantry school there is an insignia of a blue shield with a white sword on it and the motto, 'Follow me!' written on it. That's exactly what he did."

So that was what happened on Hill 202 on 16 and 17 June 1952. Bob Renneman received the Distinguished Service Cross for gallantry in action and the respect of his fellow soldiers. Friend and Foe. The action never received press coverage, nor is it recorded in the history books. But those who knew Bob Renneman and those eyewitnesses that were there will never forget. Leadership, honor, integrity; he did indeed have them all.

Follow me! To give the command and have others follow, is that not what leadership

is all about?

USO, NFL HONOR **ARMY RANGERS**

BAGRAM AIRFIELD, Afghanistan - The stars came out in the afternoon here one Dec. 16, highlighting the construction of the Pat Tillman USO Center, located near the airfield passen-

terminal. ger ground symbolic breaking ceremony kicked off a United Service Organizations (USO) Christmas Holiday tour, featuring both military, sports and Hollywood star power.

Gen. Richard B. Myers, chairman of the Joint Chiefs of Staff; John Elway, National Football League legend and Super Bowl champion; and Ed Powell, USO president; joined Maj. Gen. Eric T.

Olson, Combined Joint Task Force-76 commander, on stage to officially dedicate the facility in memory of Army Ranger Pat Tillman.

General Olson explained the significance of the 2.300 square-foot building honoring the former NFL star who left professional football to serve as an Army Ranger. After serving tours in Iraq and Afghanistan, Specialist Tillman was killed in April 2004 in the Khost province during a firefight with insurgents.

"This is going to be a very important and popular place," he said. "What made Pat Tillman a hero, wasn't the fact that he died for his country, it was that he was willing to die for his country," quoted the general from an article about the Soldier by Washington Times Reporter John Feinstein. ... "That's what makes you all heroes too."

General Myers praised the significance of the new facility as a symbol of deployed troops' dedication to mission success and to the partnerships they have developed with the people of Afghanistan. He also thanked the NFL for the organization's \$250,000 contribution, which made construction of the new facility a reality. The general concluded by lauding the USO for "following the military wherever it goes" and for managing the facility when it opens in early February.

On behalf of the National Football League, John Elway shared his thoughts on the sacrifices of those who serve.

"Knowing the opportunities the NFL offers ... it had to be a huge deal for Pat to walk away, to come here and to join forces with you all. In my mind, he's a hero and to me, you are all heroes because you're working your tails off so we can continue living the lives we do in the U.S.A.," concluded the NFL

Hall of Fame legend.

Sara Farnsworth, who is the USO Vice President; Leeann Tweeden, Sports Show Co-Host and Model; Robin Williams, Comedian and Oscar-winning Actor; and Blake Clark, Comedian and Actor, also attended the event and joined in the building dedication by digging in the construction grounds.

U.S. Army engineers, designers and local Afghan construction crews are currently working around the clock to

complete the two-story structure in time for the Super Bowl on Feb. 6. Funding for the \$450,000 project has been provided by the NFL and the U.S. Army.

Upon completion, the center will feature: a 36-person television room with a 42inch plasma TV, kitchen area, an internet café, a 10-person X-Box gaming center, a 41person coffee bar, a morale call area, a small shoppette and male and female flushing toilet

facilities. The craftsman mission-style interior, featuring rooms of various colors, geometric designs and vaulted ceilings, is designed to give customers a homey feel, said the project officer Capt. Jason Holstead, 416th Engineering Command. Facility Engineering

The exterior is reminiscent of a Texas hill-country ranch home with stone facades. dark wooden siding and exposed beams. Adding to the down-home theme, Specialist Mark Silvia, 210th Engineer Detachment from New Hampshire, also designed a 3,000 squarefoot porch to provide more places for service members to relax during the warmer months.

"The USO requested that the center have a comfortable coffee house feel to it," said the captain. "I believe this place is going to be the hottest spot on

all of Bagram."

Korean War Soldier Finally Comes Home

HOUSTON - Billy Donahoe's family shed tears of happiness as the Korean War veteran returned home to be buried.

Donahoe was a 26-year-old Army master sergeant when he was declared missing in action 54 years ago after the Battle of Chosin Reservoir.

"There is sadness, and there is joy that he is finally home," said Linda Ander-

son Watley, his niece.

It was three years ago when the remains of 11 Army infantrymen killed in the battle were discovered in a mass grave. Earlier this year, Donahoe's family learned from military officials that his could be among them.

among them.
"We always thought this day would come. Today, I would say I feel hope," said Harry Anderson, Donahoe's nephew.

"That's why we reserved the cemetery plot next to his mama." Donahoe was buried Tuesday beside his mother, Sudie Donahoe Fontenot, in a family plot.

Anderson said the hope he feels after more than five decades of uncertainty should be extended to all Americans, particularly those with loved ones serving in Gulf War II.

Army Maj. Scott Erdo delivered to Donahoe's family a copy of the report of his death compiled by the Joint POW/MIA Accounting Command at Hickam AFB, Hawaii. He said he didn't think the family gave up hope. "The military made this family a promise,"

Erdo said. "What this says to all the families in the military is, we will not give up until every fallen soldier is recovered."

Donahoe was a Marine veteran of World War II who joined the Army in 1946. "Full of adventure, full of love and not wanting to sit still for any length of time, you know," Anderson said. He'd been in Korea "for only a few days," relatives said, when they received word he was missing.

Three years later, the Army declared him dead. After the discovery of the remains, military officials asked relatives for a DNA sample to aid in the identification, but the process became complicated because Donahoe had been adopted. Army dog tags and dental records finally confirmed his identity.

Donahoe was buried beside his adoptive mother. "She went to her grave thinking that Billy was still alive and that he would come home from Korea," Anderson said.



NEW CITIZENS IN **AFGHANISTAN**

For centuries, the freedoms and opportunities of the United States fueled the dreams of the oppressed. Millions of people overcome great obstacles to travel there, looking to live the "American Dream."

For 17 members of the Coalition serving in Afghanistan, the American Dream became a reality as they took the oath of citizenship at Bagram

Air Base Oct. 1.

The National Defense Act signed by President Bush last year legalized the naturalization of U.S. service members on foreign soil, allowing these 17 Soldiers to become the first to take the oath overseas. "The people around you are welcoming you as citizens with open arms," said U.S. Ambassador to Afghanistan Zalmay Khalilzad during the ceremony. "You are able to pursue the dreams and high ideals that are part of the American creed."

Ranging in rank from private first class to staff sergeant, these 17 Soldiers represent 13 countries, but each willing to fight for the country they now call "home." "I can't be any more proud of bringing the pride and honor of being a citizen to people who are defending America," said Eduardo Aguirre, director of U.S. Citizenship and Immigration Services. "It's important to defend our freedom, it's not cheap; it costs blood.

Each of these Soldiers is willing to pay that price." Spc. Christian Rendonvelasquez is one of the Soldiers willing to pay the price to be free. A native of Colombia, Rendonvelasquez has lived in the United States for 16 years and is the last member of his immediate family to become a naturalized citizen. He is also the first person in his entire family to serve in the U.S. military. "After 9/11 I thought it was

my duty as an alien resident to help in the fight," said Rendonvelasquez, a member of 2nd Battalion, 265th Air Defense Artillery Regiment. "Now, I think it's the best feeling in the world to know I am serving my country."

Non-citizens are able to serve in the U.S. military, but they are restricted to an eightyear period of service. There are other limitations as well, such as the level of clearance they can receive and the ranks they can obtain. These restrictions spurred one Soldier, Ronald J. Carrion, CJTF-76, to work hard to become a citizen. "I've been in the Army for four years," said Carrion. "I enjoy serving, and I want to become a warrant officer.

I knew to do that, I needed to become a citizen." Carrion moved to the United States from Ecuador 12 years ago. "My father was looking for a better future for us. He's still working on attaining some of his goals, but I know we've lived

a much better life."

Now that he's become a citizen of the United States, Carrion is able to continue pursuing his goals within the military. He said one thing has changed, however. "Now, I am serving my country."

OLIVER NORTH IN AFGHANISTAN

Oliver North may be best known for his involvement in the Iran-Contra scandal in the 1980's, but many troops here in Afghanistan looked at retired Marine Lt. Col. Oliver North, now a best selling author and Fox News correspondent, as an

American hero.

North was in Afghanistan to cover the first overseas naturalization ceremony ever conducted by the U.S. Citizenship and Immigration Services. Seventeen Soldiers took the oath of allegiance, completing the diffi-cult path of becoming American citizens. "I got to be a part of a great ceremony today where 17 young Soldiers got to be American citizens," said North.

"These are people who came to our country, volunteered to serve in our Armed Forces and who respect the values of freedom and liberty we're now sharing with the people of Afghanistan."

Earlier in the day, North and his crew covered the Combined Joint Task Force-76 shoulder sleeve insignia ceremony. The ceremony also marked the 63rd birthday of the 25th ID (L). Maj. Gen. Eric T. Olson, CJTF- 76 commander, and Command S gt. Maj. F ranklin G. Ashe, CJTF-76 command sergeant major, awarded Tropic Lightning "combat patches" and Global War on Terrorism Expeditionary and Global War on Terrorism Service medals to troops.

Covering the military and showing people back home what deployed troops are accomplishing is a passion for North. "I really do believe the American people deserve to see how well their sons and daughters are performing in very, very difficult circumstances," North. "This is anything but comfortable. We've got some of the finest young people we've ever had serving in the uniform of the armed forces of the

United States.

The American people deserve to see them when they're out there putting their lives on the line, defending us from people who would take our lives in a heartbeat if given the chance."

North's visit to Afghanistan was brief, but not lacking in eventfulness. He had time to ac-Soldiers the company Schofield Barracks' 58th Military Police C ompany on a presence patrol around Bagram village. "I think it's great," said Master Sgt. Peter Ladd, 58th MP Co. tactical operations noncommissioned officer. "Oliver North is a former service member himself, he takes a lot of pride in the military and the Soldiers know a lot about him. This is great for the morale of the Soldiers, for our unit to be picked to escort him."

North climbed into the cramped confines of a high mobility multipurpose-wheeled vehicle for a two-hour patrol around the airfield. It was a relatively uneventful patrol, He said, "I have the best job in the world, because all I do is hang around

with heroes like you."

TO THE YALU AND BACK

17th Infantry Regiment, only American unit to make it there

By DON MOORE Charlotte Sun, Port Charlotte, FL The flag was made by the people of Hyesanjin in anticipation of the coming of U.N. forces.² MacArthur, a fabled five-star general who made his reputation as an astute commander in World War I and again in World War II, was on a roll in Korea at the beginning of the conflict.

Two months earlier his forces cut off the North Korean

Cpl. Larry Haynes and the men of the 17th Infantry Regiment, 7th Division stood on the frozen bank of the Yalu River. The geographically significant stream snakes its way between North Korean and Communist Manchuria. It was Nov. 21, 1950, the Korean War had been raging for five Months.

They were the only American unit to make the march all the way to the Yalu during the war.

way to the Yalu during the war.

They took this objective which Gen. Douglas MacArthur; the Supreme United Nations Commander wanted and then pulled out and began 3advancing to the rear.

The 17th Regiment had battled its way north from Iwon, on the east coast up the Korean peninsula. Against persistent Chinese resistance they took Hyesanjin, just south of the river, just before Thanksgiving 54 years ago. Col. Herbert Powell, commander of the 17th Regiment, had his picture taken along the river's southern bank holding one end of an American flag surrounded by seven of his half-frozen G.I.'s. The picture, distributed by International News Service to commemorate the occasion a few days after it took place, notes.

Army's attack into the south by severing the enemy's supply line with his gutsy but tricky landing at Inchon. It caused the North Korean's initial offensive to collapse.

The 7th Infantry Division, together with segments of the 1st Marine Division hit the beach at Inchon on Sept. 15, 1950. Task Force Seven, some 70,000 infantry and marines, arrived off shore in four aircraft carriers and 315 additional ships. Because of the extreme rise and fall of the tide at Inchon Harbor it was a hazardous amphibious assault, which Mac Arthur's troops pulled off without a hitch. Within days the 1st and 7th Divisions had relieved the pressure on the American 24th and 25th Divisions together with the Republic of Korea troops who had been taking a pounding from superior enemy forces further to the south around Pusan.

After Inchon the 1st Marine Division made it¹s historic 75-mile march from Hungnam, along the east coast of the Korean peninsula, north to the Chosin Reservoir. Then they marched back under impossible weather conditions confronted by overwhelming enemy forces.

Of the 22,000 marines in the reinforced division that started the trek 6,0000 were killed and wounded and another 6,000 who sustained frostbite. Ten Medals of Honor were awarded members of the 1st Marine Division and 70 Marines received the Navy Cross, this country's second highest award for valor under fire, before they made it back to the beach at Hungnam, where they were rescued by the U.S. Navy, hordes of Chinese and North Korean troops in hot pursuit.

Haynes and the men of the 17th Infantry Regiment, 7th Division left Inchon after their successful invasion in conjunction with the marines and headed south for Pusan.

Once there they took troop ships around the tip of the Korean peninsula and landed along the east coast at Iwon, north of the 38th Parallel that divides the country between north and south. On Oct. 31, 1950 the 17th Regiment disembarked and began its long hike to the Yalu.

It would take the 5,000-man reinforced 17th Infantry Regiment the better part of a month to reach Hyesanjin, 125-miles into the interior of North Korea. MacArthur assured us we'd be home for Christmas, Haynes recalled. That's why we weren't properly clothed for the extremely cold weather we encountered on the way up and back from the Yalu. The general also said the Chinese weren't going to get into the war. He was wrong on both scores.

Before it was over we were outnumbered about 10 to 1 by mostly Chinese troops, the 73-yearold North Port man said. 3Much of the time we were surrounded by the enemy.1 The Marines from the 1st Division suffered the same fate at the same time. They were poorly clad, under supplied and lacked the manpower to confront vastly numerically superior Chinese forces as the slogged their way up the west side of the Korean peninsula to the reservoir at Chosin. Like Cpl. Haynes and his buddies they spent much of their time going and coming surrounded by enemy forces and under constant attack. 3lt was a two-lane, winding, mountain road all the way up to Hyesanjin with a steep drop off on one side. The weather was getting worse and worse as we fought our way north, he said.

It was early December and I remember seeing a thermometer outside in the snow one day that read minus 39 degrees. We weren't equipped for this kind of weather. It was about this time they began encountering strong resistance from Chinese forces.

MacArthur, whose headquarters were in Tokyo thousands of miles away from the front lines, initially questioned the involvement of Chinese soldiers in the Korean conflict despite what his front line commanders told him.

Haynes and the men of the 17th Regiment had no doubts that Chinese were involved in the conflict because they had been killing them by the hundreds. When their regiment reached the Yalu.

MacArthur wanted to continue north into Manchuria and take on the Chinese on their home turf. President Harry Truman wouldn't sanction such a battle plan.

The president and his advisors decided such an incursion would launch World War III. Truman ordered the general to pull his troops back from the Manchurian border.

It was just about Thanksgiving 1950 when Haynes and his regiment reached the Yalu. The weather was well below zero, the 17th Regiment was greatly outnumbered by enemy forces although they didn't realize how badly until a few days later on their advance to the rear, Haynes said. He was a 19-year-old machine gunner at the time.

The Chinese had come across the Yalu and taken the high ground before we knew what was going on. Then they started bombarding us with artillery and night attacks, Haynes said. The enemy would smoke opium before they

charged as they blew bugles and played loud music during the dark hours. It worked on us young guys1 minds, he recalled. As it got daylight there was total silence. Then all of a sudden they came right up at you like a swarm of ants screaming and yelling and firing their weapons. The mental strain and the cold were probably as much of a problem as the Chinese shooting at you. A lot of our guys lost it. They threw their weapons away and gave up, he said. I'm not going anywhere, 1 they would say. Then they would sit down along the side of the road and freeze to death. The high water mark for Cpl. Haynes and the other eight soldiers in his machine gun squad came on the last half of their god-awful return march to the coast late in December. ³We came to this one pass. The Chinese had blown up the bridge across this deep gorge. Our whole convoy came to a halt. For the next 12 hours, while the bridge was being rebuilt, we were susceptible to enemy fire from higher ground, he said. ³This young lieutenant of engineers asked that some bridge sections be parachuted into us.

Within hours he and his men had spanned the chasm with a new bridge. In the meantime, Haynes and several other machine gun squads formed the rear guard. It was their responsibility to hold back the overwhelming onslaught of enemy troops who had the Americans surrounded with their backs against the deep precipice.

Haynes and his squad, together with the other machine gun squads in his regiment, held the line. By the time the 17th Regiment reached the protective gunfire of the U.S. fleet they were within 20miles of the beach at Hungnam. At that point what was left of Haynes unit converged with the remains of the 1st Marine Division that had suffered the same fate as they fought their way back from Chosin.

It was Dec. 20, 1950 and the enemy was right on our butts. We also had tens of thousands of refugees with us trying to escape the Chinese, too, he said. ³We lined up our tanks and our howitzers to keep the enemy at bay along with our naval guns lobbing shells at them. As we got aboard LST's (transport ships), with 100,000 refugees who escaped with us, our demolition crew b lew up the tanks, guns and the city of Hamhung.


Three days later they arrived at Pusan and the relative safety of South Korea. As he completed his story, while sitting at a table in the comfort of his North Port home, former Cpl. Larry

Haynes, 7th Division said a lifetime later, by the time the 17th Regiment reached the ships at the coast we had bottomed out. We crowded aboard the LST's with the refugees. It was at that point; I finally realized we made it.



Life Member John Graham is always doing something for our Association. Last year he visited The Buffalo Trace Brewery in Kentucky, and obtained for us several Buffalo items to sell and Raffle off for our "Buffalo Bill" Scholarship Fund.

She put me in contact with their supplier and I was able to obtain 200 of them at a discount. The ones with the key chain cost us \$3.80 and the ones for a necklace, without the key chain were \$3.40.

We'll sell them at our Reunion for \$5.00, with the profit going to the Buffalo bill Scholarship Fund.





are on exhibit.


After our drive through and walking tours of the Wild Animal Park, we'll stop for a Grilled Chicken Sandwich, French Fries and a Soft Drink.
